

# Why the need for the Handbook?

The need arises with the understanding that we your facilitators and educators wish to help you grow into individuals with self-esteem and confidence. For this it is necessary that we create a space for you to accept yourself, acknowledge your fears, appreciate your courage and be there for your co travellers. This handbook will guide, help and be there for you in all times.



#### HOW TO USE THIS HANDBOOK

This handbook is intended to help you to:

- Navigate the details of what a safe space entails at HIS.
- Definitions of unsafe behavior that need to be avoided and prevented at all times
- Offer guidelines on acceptable and unacceptable behaviors in your capacities as a learner and friend
- Understanding your rights / responsibilities
- Understand the formal procedure of registering a complaint and its resolution
- Reach out for immediate support if you or someone in the ecosystem is in distress



## OBSERVE



The eyes are the window to the soul and this is true especially when we need to use them with a sense of awareness. The age demands that the observing skills are at their best to see things not at the periphery but deeper. The actions that will follow will be on this skill of observation.

I am sure you are aware of what unsafe behaviours look like, let us discuss how you can keep your eyes open for them and stay alert. We must keep in mind that a victim does not always find it easy to express that they have been abused, so it takes empathy and sensitivity on our part to dig deeper.

What are the indicators that you should be looking for?

## IN YOURSELF

- Does someone's comments online or offline hurt or offend you?
- Do they continue despite your requests to make it stop?
- Does someone hold or touch you in a way that makes you feel uncomfortable?
- Does someone or some groups of people withhold their friendships with you?
- Does someone make you feel uncomfortable with the content they share with you?





# INOTHERS

Does someone you know appear to be suddenly disinterested in learning activities?

- Does someone you know appear anxious and fearful, especially around a particular facilitator or staff member?
- Does someone you know have visible bruise marks on their body?
- Does someone you know seems to be unhappy at home or has troubled relationships?
- Does someone you know have an unusually low attendance record?
- Does someone you know harm themselves or display suicidal tendencies?



- Name calling
- Any form of racial abuse
- Inappropriate sexualized behavior with peers or facilitators .We understands that some of these phrases are heavy, but it is very important to know them to prevent them. Unsafe behaviors are not limited only to the ones mentioned above. Each of you is unique and it is perfectly normal to have your own list of unacceptable unsafe behaviors.



# WHAT ARE THE GUIDELINES FOR SAFE AND HEALTHY DAILY INTERACTIONS?

Every learner at "Connect "is worthy of respect, regardless of gender, religion, physical appearances or abilities. As a thumb rule, always be kind!

- Be cautious of the language you use in your interactions. Certain slang and colloquialisms may be offensive to learners of certain communities, genders and disabilities.
- Please refrain from making comments on peers' dressing sense. Everyone is allowed to maintain their individual style of dressing as long as it adheres to the dress code.
- Specifically for online interactions, ensure that you are responsible for the data you share and receive. Avoid sharing sensitive information such as credit card numbers, passwords, home addresses online. However deep your friendships may grow to be, please avoid sharing images and video





Follow basic netiquette during online classes.

• Be civil and polite on social media. Even if you disagree with someone, please do so assertively not aggressively. Don't forget to leave the platform a little kinder than you found it!

### WITH YOUR FACILITATORS

All our facilitators are highly qualified experts in their fields and they are committed to sharing that with you. Please show them the respect they deserve. Our facilitators are more involved in your learning and you will be spending a lot of time with them by your side. Please ensure that a professional distance is maintained at all times. You are not obligated to meet with any facilitator in private spaces outside of school for personal matters. It is best to have even private conversations in designated counseling rooms or easily accessible areas. Specifically for online interactions with facilitators, please ensure that you only use the digital platforms mandated by HIS-CONNECT (Google Classrooms, Google Mail, Google Chat, Myschoolone). You are not obligated to communicate with any facilitator on WhatsApp or personal social media account.

## ABOUT POCSO ACT

According to the POCSO Act (Protection of Children from Sexual Offences) Act, a child is entitled to get their statement recorded at their home, not have contact with the accused during the investigation and not get detained during the investigation. The special courts stipulated under the POCSO Act are also child-friendly. There are provisions such as making a child-friendly atmosphere in the court premises by allowing a family member, a guardian, a friend or a relative, in whom the child has trust or confidence, to be present.

#### HISP CONNECT SAFE SPACE COMMITTEE

### CHILDREN WITH SPECIAL EDUCATION NEEDS (SEN)

Children with SEN are just as vulnerable to unsafe behaviours, if not more. And it becomes our responsibility to ensure that they feel safe in HIS-CONNECT. We also realise the same guidelines we have for other children will not apply for them. This is for the sole reason that physical touch is central to the way we communicate with children with SEN and could present a grey area. Please be assured that our facilitators are trained in all aspects of working with children with SEN. Nevertheless, we would still want to these children and their families to be aware of the guidelines put in place especially for their safety.
